Board of Trustees for 2023

Key points from By-laws

- ▶ Accountable to the General Body of the SMM.
- ▶ Trustees have fiduciary responsibilities – act in the best interest of SMM, provide guidance to EC for the same end goal
- ▶ Manage SMM's general funds in a responsible manner and disburse seed funds to the Executive Committee if needed for special projects and events

BOT is involved only when...

- ▶ EC wants guidance or consultancy for big events or activities
- ▶ EC needs clarity on “is this right thing to do per our charter”
- ▶ EC has internal debates or conflicts that could use an impartial body to help resolve

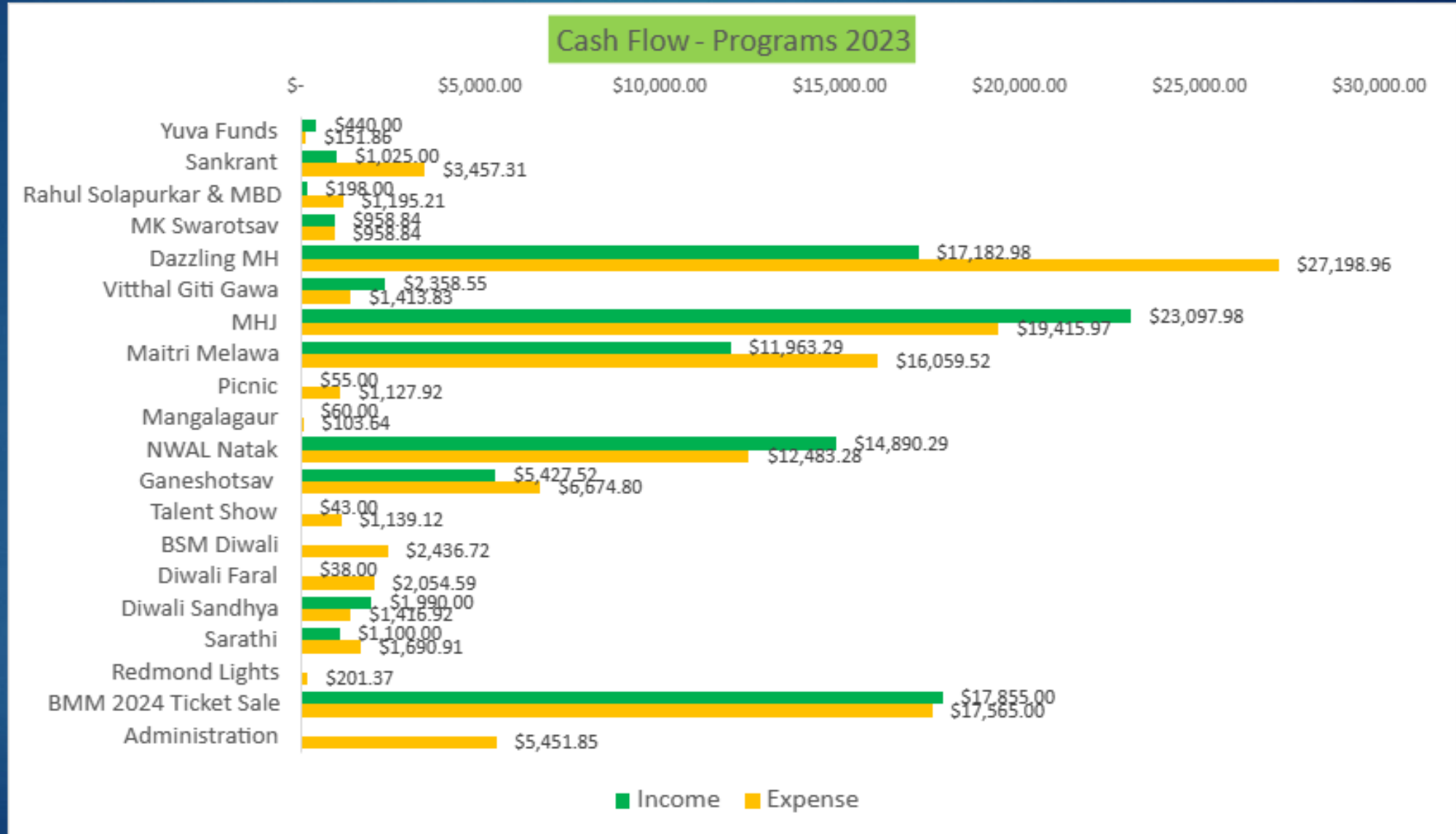

2023 Cash Flow – Programs



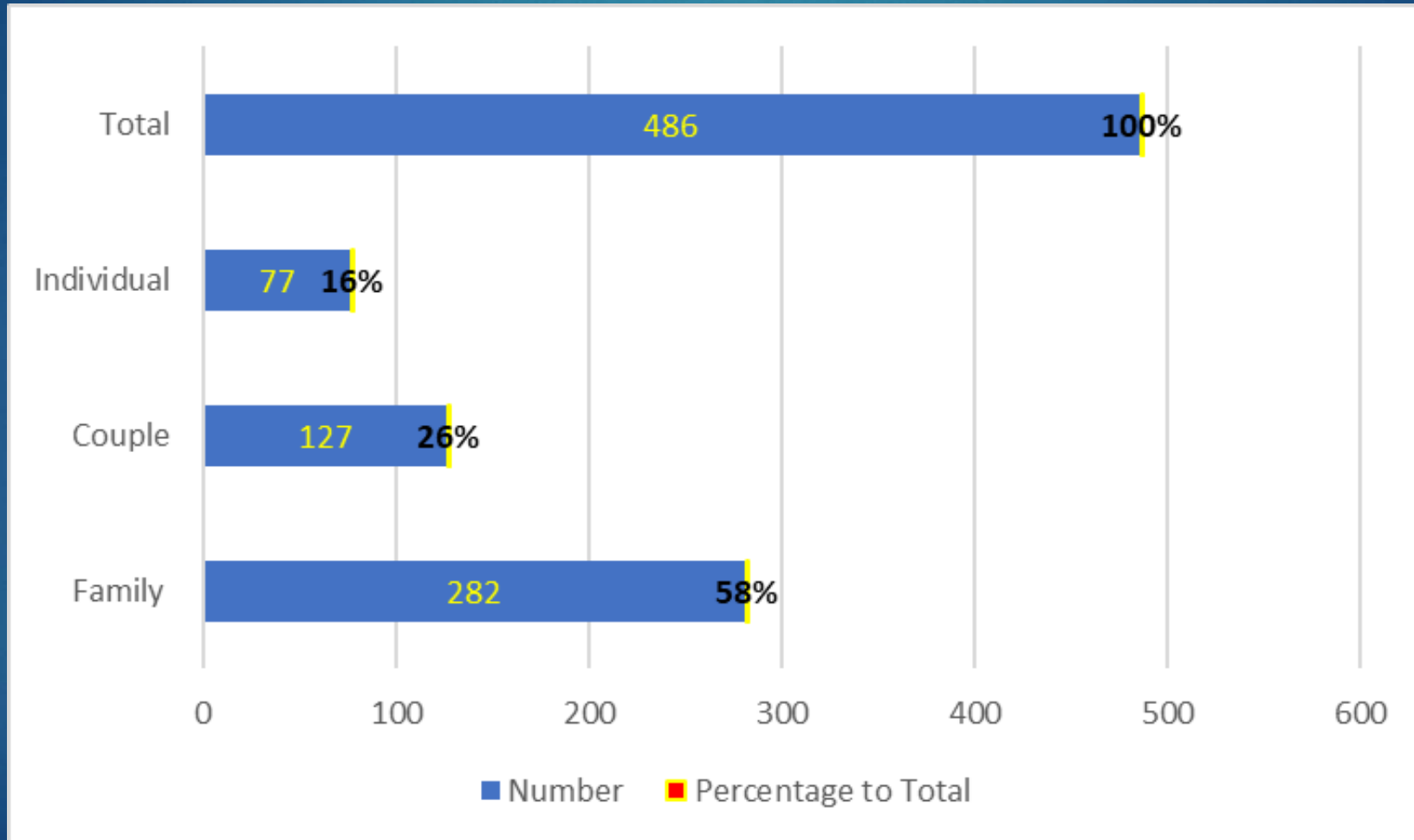

Amendment 1

- ▶ Elected EC member- avoid conflict of interest Any elected EC member , who would want to serve on SMM executive committee/ SMM office bearer , cannot hold any significant position/ office position in any other organization that has parallel or similar interest as Seattle Maharashtra Mandal . This way conflict of interest can be avoided. And the person working on Seattle Maharashtra Mandal 's Executive committee can do justice for the responsibility they take up in SMM .



Amendment 2

- ▶ Upon completion of the first term of three consecutive years in good standing, the incumbent Board of Trustee is eligible for a second three-year term through election. The election for the open seat shall be done by voting on all eligible nominations received by the Executive Committee prior to a pre-stipulated date and time.
- ▶ Unlike Executive Committee nominations, the Board of Trustee nominations, including the incumbent's nomination, shall be made by another individual in the community, and not through self-nomination.
- ▶ The incumbent shall not be elected by default except, in the absence of other nominations received, and the incumbent being the sole nomination.
- ▶ Individuals from the same family shall not serve back-to-back terms, a minimum of three-year gap is required between the terms in such cases. The intent is to promote equal participation from all qualified SMM members interested in serving the community.
- ▶ Board of Trustees and EC, both should participate equally and share their updates during the periodic meeting scheduled either every 3 or 6 months.

Amendment 3

- ▶ Every year, after a new EC is formed and roles are identified, if there are openings and all seats are not filled up in EC then EC team can request an existing member who is completing 3-year term but willing to continue for only an additional one year.
- ▶ Conditions –
- ▶ This can be implemented if more than 66% of the new EC votes for it.
- ▶ For the 4th year term extension, the same role as prior years is not guaranteed to the candidate



Amendment 4

- ▶ ‘BMM Representative’ position related Reform.
 - ▶ BMM Representative will be an Office bearer position. Where BMM Rep will not participate in weekly meeting and annual operation of SMM EC. BMM Rep must be introduced to EC in any meeting in beginning of the year. BMM Rep must be included in BMM related events, emails, discussions. BMM Rep can be added in SMM group email and SMM WhatsApp group with OBs to communicate BMM related communication.
 - ▶ As per SMM constitution SMM President can be BMM Rep. (limitation : when one of the SMM members is on BMM EC, this will change). This is mentioned below.
 - ▶ Voting by this person in the BMM Election will be transparent.
 - ▶ Maximum term limit is imposed on this position. The 2-year term of the BMM representative shall align with the upcoming BMM executive committee's term & timeline



Amendment 4 cont...

► BMM REPRESENTATIVE

- The BMM representative shall serve as the liaison between the current SMM committee in-force and the Bruhan Maharashtra Mandal herein referred as BMM. The BMM representative shall serve as a brand ambassador for all of the SMM's initiatives to BMM and various Marathi mandals across the United States. The BMM representative shall also be responsible to communicate various initiatives and important communication from BMM time to time to the member base of SMM via the committee communication.
- One of the important job responsibilities of the BMM representative is to cast the vote(s) in accordance with the committee as the official committee representative in the BMM bi-yearly elections for BMM's Executive Committee and Board of Trustee positions. The BMM representative shall take the inputs of the committee by a binary voting system with a tiebreaker vote from the president, if necessary, before voting for any BMM positions on behalf of SMM. He/She shall cast the vote in front of at least 3 other committee members including the SMM President electronically or on a ballot paper. If voting is done by ballot paper, then he/she shall put the ballot paper in a sealed envelope with AMM President's signature on the sealed ends of the envelope to prevent tampering. SMM Committee members can decide how this sealed envelope should be delivered to BMM Election officials – By mail or through a person that is going to attend the BMM Annual General Meeting during BMM Convention.
- The 2-year term of the BMM representative shall align with the upcoming BMM executive committee's term & timeline, and one person shall not hold the tenure or duties of the BMM representative for more than 2 terms, a total of 4 years in succession with a lifetime maximum of 8 years (4 terms). This shall be the AMM committee position that has off-sync tenure from the current committee in force for that calendar year typically ranging the tenure from January 1st to December 31st.
